Dear Stamp Dealer:

TRIPEX STAMP FAIR 2014 will be held on Saturday, June 27 and Sunday, June 28, 2014 at St. Aloysius Gonzaga Hall, 1435 South 92nd Street, West Allis, Wisconsin. Prices for booths with a 12-foot front and a 12-foot back table is \$150.00. Due to a shortage of tables, booths #3, 6, 9, and 20 have 12-foot front tables, but only 8-foot back tables and these booths are priced at \$140.00. If any second or third booths are required you may deduct \$10.00 for each additional booth required.

Applications for TRIPEX Stamp Fair 2014 should be made on the enclosed form and mailed **with payment in full** (checks made out to TRIPEX STAMP FAIR) to the Bourse Chairman, Robert Mather at the address noted below. Application forms and payment in full must be received by the Bourse Chairman no later than June 1, 2014

TRIPEX STAMP FAIR 2014 will exercise reasonable care for the protection of the dealer, his or her representatives, and wares. Twenty-four hour security will be provided. However, neither the officers or the members of the North Shore Philatelic Society, the American Topical Association, Chapter 5, the Waukesha County Philatelic Society, nor the bourse chairman will be responsible for any losses during the show.

Sunday, June 28, 2014 - 10:00 A.M. to 4:00 P.M.
